#### **Processing of personal details**

Vandra Skateboards processes your personal details when you register for the Dutch Ultraskate, you provide those details to us by yourself. We process the following personal details:

- First and last name
- Gender
- Date of birth
- Nationality
- Home address
- Phone number
- e-mail address
- contact person in case of emergency
- t-shirt size
- Bank account number

#### **Purpose of the processing of personal details**

Vandra Skateboards uses your personal details for the following purposes:

- Processing the payment of the entry fee
- Being able to contact you if necessary
- Placement in the correct race category

#### **Storage of personal details**

Vandra Skateboards will follow this procedure when it comes to storage of personal details:

- When registering for the Dutch Ultraskate an account will be created, your account will contain the personal details listed above (section 'processing of personal details').
- An account can be deleted at any point in time, however, for participating in the Dutch Ultraskate a valid account needs to be kept until after the event
- Your account will not be automatically deleted since it may be used in future editions of the Dutch Ultraskate
- A digital copy of the invoice generated after registration will be kept offline on an external hard drive for five years, this is obligatory by Dutch law.

#### **Sharing of personal details with third parties**

Vandra Skateboards will not share personal details with third parties unless this is required by law. First and last name, gender and nationality will be made public on social media in the last month before race weekend in the form of a riders list. #### **Viewing your data, editing or deleting**

You have the right to view your personal details at any time by signing in to your account. When signed in to your account you will also be able to correct your data. If you want your account to be
